Transactions at Point-of-Sale (POS) locations	\$0.00	No fee for Personal Identification Number (PIN) or signature based POS transactions in the U.S.

ATM withdrawal (in-network)	\$0.00	No fee for in-network ATM withdrawals. "In-network" refers to the Wells Fargo Bank ATM Network and the MoneyPass ATM Network. Locations can be found at wellsfargo.com/locator/ and moneypass.com/atm-locator.html .
ATM withdrawal (out-of-network)	\$2.25	This is our fee. "Out-of-network" refers to all ATMs outside of the Wells Fargo Bank ATM Network and the MoneyPass ATM Network. You may also be charged a fee by the ATM operator, even if you do not complete a transaction.
Teller-assisted cash withdrawal (OTC)	\$3.00	You are allowed 1 teller-assisted withdrawal at Visa member bank and credit union teller windows for each deposit in a calendar month for no fee.

ATM balance inquiry (in-network)	\$0.00	No fee for in-network ATM balance inquiries. "In-network" refers to the Wells Fargo Bank ATM Network and the MoneyPass ATM Network.
ATM balance inquiry (out-of-network)	\$0.75	This is our fee. "Out-of-network" refers to all ATMs outside of the Wells Fargo Bank ATM Network and the MoneyPass ATM Network. You may also be charged a fee by the ATM operator, even if you do not complete a transaction.
Cardholder alerts	\$0.00	No fee for email, phone or text messaging cardholder alerts. You may be charged a fee by your mobile carrier or internet service provider.
Customer service	\$0.00	No fee for calling our customer service line, including for balance inquiries.
Online access to card account	\$0.00	No fee for accessing account information at EPPICard.com .

International ATM withdrawal	\$2.25	This is our fee. You may also be charged a fee by the ATM operator, even if you do not complete a transaction. International transaction fee also applies.
International transaction fee	3%	Of the U.S. dollar amount of any type of transaction, including ATM withdrawals. Transactions completed in U.S. Territories are not international transactions.

Card replacement	\$4.00	You are allowed 1 card replacement per benefit period for no fee. Standard card delivery is 7 to 10 calendar days.
Expedited card delivery	\$14.50	If you request your replacement card to be expedited rather than receiving it by regular mail you will be assessed the expedited card delivery fee, in addition to any applicable card replacement fee. Expedited card delivery is 3 to 5 calendar days.
Funds transfer via Interactive Voice Response (IVR-phone)	\$1.50	Each transfer from your prepaid debit card to your personal bank account will be assessed a fee.

Your funds are eligible for FDIC insurance and will be held at or transferred to Wells Fargo Bank, N.A., an FDIC-insured institution. Once there, your funds are insured up to \$250,000 by the FDIC in the event Wells Fargo fails, if specific deposit insurance requirements are met.
